**FURTHER ON MARKET PURCHASE OF CONVERTIBLE NOTES**

A wholly owned subsidiary of Dragon Mining Limited ("Dragon Mining" or the "Company") has purchased a further 100,000 Dragon Mining Convertible Notes ("Notes") at an average cost of \$0.91 per note for a total of \$91,300 including costs.
