FURTHER ON MARKET PURCHASE OF CONVERTIBLE NOTES

A wholly owned subsidiary of Dragon Mining Limited ("Dragon Mining" or the "Company") has purchased a further 1,904,762 Dragon Mining Convertible Notes ("Notes") at an average cost of \$0.825 per note for a total of \$1,576,614.37 including costs.
